

# 三. 挑战

- 沟通、执行较困难
  - 纸供应链涉及很多贸易商、纸厂、浆厂等
  - 宜家供应商采购量有限，影响力小
- 追溯性要求树种拉丁学名、浆厂
  - 较难验证
  - 纸厂从浆厂贸易商买浆
- 纸市场近一年的不稳定，加大采购难度
